RELEASE AND INDEMNIFICATION AGREEMENT

I am the Parent/Guardian of the above named Participant who is under eighteen years of age and am fully competent to sign the Agreement. In consideration of the educational experiences described below provided by The University of Alabama to my child, I, the undersigned parent or legal guardian, desiring for my child to participate in the voluntary *Crimson Music Camp*, including any field trips, (the "Program") offered by the School of Music at The University of Alabama, the undersigned, on behalf of my child and myself, knowingly and voluntarily **waives, releases, and discharges any and all claims for damages for personal injury, including death**, which my child may suffer as a result of my child's participation the Program. This release is intended by me to **discharge in advance** The Board of Trustees of The University of Alabama, its officers, employees, and agents, (collectively referred to as the "University") and private landowner(s) of locations or sites used by the Program, from any and all liability to me and to my child for damages as a result of my child's participation in the Program, even though that liability may arise out of the University's or a private landowner's negligence or carelessness. I agree to be solely responsible for any and all medical expenses and costs that my child might incur as a result of any injury or sickness that my child may suffer while participating in the Program. I am fully aware that the Program, and its activities, **involves risks and hazards**. The activities and risks include, but not are limited to: (i) on and off-campus travel to Program locations and sites and traveling to and from those locations and sites; (ii) as a passenger in a van or other type of vehicle, injury or death while the vehicle is stopped, traveling on roads and highways, or traveling off-road due to either foreseen or unforeseen events; (iii) injury from poorly maintained streets, sidewalks and other municipal and/or public facilities; (iv) criminal acts against tourists and visitors; and (v) indoor or outdoor activities all of which pose risks of injury, such as cuts, bruises, sprains, and broken bones, or death; insect bites and stings, heat disorders, sunburn, or other serious or mortal personal injuries. **Knowing the types of risks associated with the Program, and its activities, including the risks noted above, may be hazardous to my child, I am voluntarily allowing my child to participate in the Program and in its activities. I, on behalf of my child and myself, voluntarily assume responsibility for any risks of property damage or personal injury, including death, that I or my child may suffer as a result of my child participating in the Program and its activities or while traveling to and from Programs locations and sites; and further I, on behalf of my child and myself, hereby release and discharge the University and the private landowner(s) of locations or sites used by the Program, from all claims for damages resulting from my child's participation in the Program and further promise not to sue the University or private landowners of location or sites used by the Program to recover damages for injuries to my child resulting from the Program.**

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND IT TO BE A RELEASE OF ALL CLAIMS AND CAUSES OF ACTION FOR PARTICIPANT'S INJURY OR DEATH OR DAMAGE TO PARTICIPANT'S PROPERTY THAT OCCURS WHILE PARTICIPATING IN THE DESCRIBED ACTIVITY AND IT OBLIGATES ME TO INDEMNIFY THE PARTIES NAMED FOR ALL LIABILITY FOR INJURY OR DEATH OF ANY PERSON AND DAMAGE TO PROPERTY CAUSED BY PARTICIPANT'S NEGLIGENT OR INTENTIONAL ACT OR OMISSION.
